The **March 4, 2020** organizational meeting of the Rockingham County Electoral Board was called to order at 9:30 a.m. in the Recreation Department Conference Room by Lisa B. Gooden, Director of Elections/Voter Registrar. Electoral Board members in attendance included: Lois 'Trish' Philon, Susan C. Threewitts, and newly appointed member, Robert 'Mike' Auchard.

Election of Chair of the Electoral Board: A motion was made by Mike Auchard, seconded by Susan Threewitts, and unanimously carried, to elect Lois 'Trish' Philon as Chair.

Election of Vice Chair of the Electoral Board: A motion was made by Susan Threewitts, seconded by Trish Philon, and unanimously carried, to elect Mike Auchard as Vice Chair.

Election of Secretary of the Electoral Board: A motion was made by Trish Philon, seconded by Mike Auchard, and unanimously carried, to elect Susan Threewitts as Secretary of the Board.

Approval of the Minutes of February 19, 2020: A motion was made by Susan Threewitts, seconded by Mike Auchard, and unanimously carried, to approve the minutes of February 19, 2020, as presented.

Canvass of Votes for the March 3, 2020 Democratic Party Presidential Primary: Members proceeded to review the 1A Provisional Votes and other election results by precincts. It was noted that there were a total of five provisional voters, with only one being a Photo ID.

Recess: The Electoral Board recessed the meeting at 3:30 PM and agreed to reconvene on Friday, March 6, at noon.

Reconvened: The Board reconvened at 12:00 PM on Friday, March 6, to complete the Canvass of Votes.

It was noted that the Photo ID Provisional was not submitted by the deadline, so that ballot could not be counted.

Members continued to finalize their review of the election results and the Abstract of Votes as noted on the following page.

Adjournment: After brief discussion, a motion was made by Susan Threewitts, seconded by Mike Auchard, to adjourn the meeting at 3:30 PM.

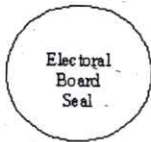
